Treasurer Jim Fulton stated the Planning Commission has approved two special land use permits and are under new business.

Trustee Matt Moser informed every one the Sewer Plant received a dividend check from Michigan Par Plan for \$1,159.44. A new BOD probe and meter had to be replaced at a cost of \$2,013.39 the old meter is over 10 years old. Bob Gerbel reported a clean opinion Audit. He stated the Plant is financially sound and in good shape. The plant is in compliance.

Chief of Police Jason Roe reported it was a rather busy month. There were 296 total complaints investigated in July. 1 for obstructing justice, 7 for driving violations, and 22 were suspicious situations. He stated there were 26 arrests, 56 traffic stops, 38 traffic warnings, 19 citations issued, 95 property checks and 27 ordinance investigations in the township. The Chief commented Glad-Peach festival went smoothly with only a few minor incidents.

Trustee Rob Harper reported North Berrien Fire Rescue responded to 25 calls in July. Station 2 well house pump seems to have a small leak along with the stand pipe. Service has been advised. The computer at Station 1 needs repair or replacement. Station has been cleaned for Glad Peach activities. Placed order for office and cleaning supplies. Hose testing results are back for review and physicals are complete.

Trustee Bryan Duffield reported all is quiet at the Cemetery.
