### COMMITTEE REPORTS CON'T

Trustee Bryan Duffield stated the Coloma Township roads have been completed for 2016.

Trustee Jim Fulton informed everyone Planning Commission is reviewing the Zoning Ordinances and updating if needed. He stated the old "Schick Motel" has been purchased and the new owner would like to updated the cottages and will need a special use permit on some of things he would like to do.

Chief of Police Jason Roe reported there were 210 total complaints investigated in September. 9 were for obstructing justice, 4 for driving violations, and 17 were suspicious situations. He stated there were 21 arrests, 70 traffic stops, 70 traffic warnings, 14 citations issued, 260 property checks and 13 ordinance investigations in the township. Chief Roe reported the 1 year contract was up for Lieutenant Wesley Smigielski on September 1, 2016. Chief Roe asked the Board to approve a 3 year contract with Lieutenant Smigielski the only changes being a 1.7% pay increase each year. Trustee Rob Harper, seconded by Trustee Matt Moser, made a motion to extend Lieutenant Wesley Smigielski's contract for 3 years with the only changes being a 1.7% pay increase each year. ROLL CALL VOTE: Kraemer, yes; Moser, yes; Duffield, yes; Harper, yes; Fulton, yes; Becht, yes; Parrigin, yes. ALL AYES. APPROVED. Chief Roe asked the Board to approve the 2016 Protocol Manuel. Treasurer Lance Becht, seconded by Trustee Rob Harper, made a motion for the Board to approve the 2016 Protocol Manuel. Trustee Rob Harper reported North Berrien Fire Rescue responded to 21 calls in September. The decision was made to purchase the new Fire Truck from US Tanker. A date needs to be decided to sit down with Sales Representative to review and sign a purchase agreement. The agreement is not to exceed \$315,000.00. The roof on the building next to the Station 1 is in need of repair and they will get prices to repair it. Trustee Harper informed the Board that \$46,595.22 will be Coloma Township's portion to purchase the Chassis for the new Fire Truck and he needed an approval to purchase it. Treasurer Lance Becht, seconded by Trustee Bryan Duffield, made a motion to approve Coloma Township's portion of \$46,595.22 to purchase Chassis for new Fire Truck. ROLL CALL VOTE: Fulton, yes; Becht, yes; Parrigin, yes; Kraemer, yes; Moser, yes; Duffield, yes; Harper, yes. ALL AYES. MOTION CARRIED.

Trustee Bryan Duffield reported there is lots of maintenance going on in Coloma Cemetery. There are bushes being planted in the new section and some trees are being taken down.
